PUBLIC NOTICE

This has furtherance to our public notice dated 10.10.2024 & Corrigendum dated 24.10.2024, the Karnataka Gramin Bank (Employees) Pension (Amendment) Regulations, 2024, is published on the Official Gazette of India on 06.11.2024. Accordingly, the date of notification is 06.11.2024

Vide this notice, we request the eligible

- **Ex-Employees** to submit the application and refund the entire final amounts received by them (the corpus comprising of Bank's contribution to Provident fund under the Employees' Pension Scheme, 1995 and the interest accrued thereon till the date of receipt by them of the amount) during their service period as well as at the time of their cessation on or before 20.11.2024 (i.e., within 15 days from the Date of Notification).
- **Family of Ex-Employees** to submit the application and refund the entire final amounts received by the deceased employee, (the corpus comprising of Bank's contribution to Provident fund under the Employees' Pension Scheme, 1995 and the interest accrued thereon till the date of receipt of the amount by the deceased employee) during their service period as well as at the time of their cessation on or before 05.12.2024 (i.e., within 30 days from the date of notification).

Alternatively Ex-employees / Family of Ex-employees can authorise the Bank to adjust these amounts from the amounts payable by the Bank to them.
