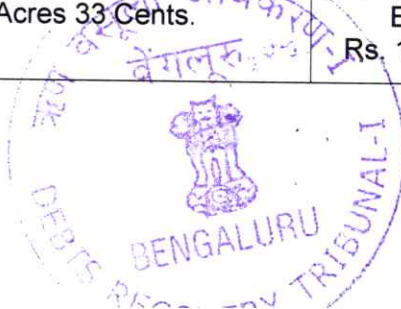
1. The reserve price below which the Properties (mentioned below) shall is

2. The amount by which the biddings are to be increased for all properties shall be **Rs.25,000/- (Rs Twenty five thousand only)**. In the event of any dispute arising as to the amount of bid, or as to the bidder, the lot shall at once be again put up to auction.
