2. TERMS AND CONDITIONS OF THE CONTRACT

1. **Eligibility criteria:** Only empanelled vendors (as on 31-05-2025) of the bank are eligible to participate in this tenders. Applications/Bids from any others will be summarily rejected.
2. **Type of tender:** Two bid
Bids must be submitted in two separate envelopes as follows:
Part A - Technical Bid: Should contain entire RFQ tender document and financial documents of the firm submitting the bid as mentioned below with seal and sign of the vendor duly filled (excluding price quote as per annexure-2):
 1. Tender documents: Invitation, General information, Terms & conditions.
 2. BIS Certification issued to the OEM.
 3. Any 3 purchase orders from the past two years, issued by any reputed scheduled commercial bank in India with a minimum quantity of 50 quantity at once.
 4. Declaration for not being blacklisted in any firm in the past 3 years as per annexure 1.
 5. Last 3 years financial statements.**Part B - Commercial Bid:** Should contain price bid duly filled as per annexure-2(rates quoted should be exclusive of GST). This should be submitted in a separate envelope with an inscription reading “Commercial Bid of Tender for supply of Security Equipment”
6. **Buyback:** Buyback of the existing FBR safe is part of this procurement. The vendor shall coordinate removal on the day of TRTL installation.
7. **Evaluation:** The Bank reserves the right to accept or reject any or all tenders without assigning reasons. Lowest bid will not be the sole criterion for selection.
8. **Validity:** This tender is valid for 12 months from the date of agreement. It may be extended for an additional 12 months upon mutual consent.
9. **Location:** Delivery and installation will be across various locations in Karnataka as per bank's requirement.
10. **Costs Included:** Quoted price must be inclusive of all charges—installation, transport, crane, labour, insurance, dismantling of old units, etc.
11. **EMD:** Not applicable.
12. **Security Deposit:** ₹5,00,000/- per category by the way of DD/Bank guarantee from any scheduled commercial bank.
13. **Time for delivery:** 14 days from the date of indent. Beyond which bank may impose a penalty of 1% of the invoiced amount per week of delay subject to a maximum of 5% of the accepted contract sum would be levied, for the delayed period, if time schedule is not adhered to.
14. **Payment:** Payment will be made within 15 working days after completion of the installation and submission of original invoice acknowledged by the Branch to the Head office address as mentioned above. Statutory deductions like Income Tax TDS, GST TDS and Work Contract Tax etc., at the prevailing rates will be deducted at source as per the directions of the statutory bodies, from each invoice.
15. **BIS Standards:** The item should meet ISI/BIS standards as per the categories mentioned in

the tender and should compulsorily have ISI/BIS mark on the equipment inside the door(should not be visible in unlocked state).

16. **Door opening:** In general Left-to-Right opening doors are to be supplied, However due to site issues if Right-to-Left opening doors are required, Vendor should supply the same at the same cost and no additional amount will be considered/paid.

17. **DETERMINATION “L1” AND AWARD OF WORKS:**

- L1 will be decided on the basis of the lowest amount quoted in the bid **under each category.**
- Bank reserve the rights to negotiate the rates where it deems necessary. In the event a Bidder is not able to fulfill the contract, the Bank has right to cancel the order and to assign/distribute the order to the other selected Bidder/s after giving 3 days notice through email.
- Wherever the quantity requirement is large and time is limited, order may be distributed by the bank at its discretion depending on the requirement to L1, L2, L3 at L1 rates with a minimum of 50% to L1 bidder, provided L2, L3... agree to carryout work at L1 rates. In case, L2, L3... does not agree to undertake order at L1 rates, entire order shall be issued to L1 bidder who has to carry out the work at L1 rates quoted by them.
