Applicant should apply in the prescribed Application available with Karnataka Gramin Bank, General Administration Wing, Premises & stock section, Head Office, Ballari, between 11.00 am to 5.00 pm on all working days by paying an Application fee of Rs. 250/- + GST Rs. 45/- (Rupees Two hundred Forty five only + GST).
2. The prescribed application form along with DD of Rs. 10000/- towards EMD amount should be submitted to the General Manager, Karnataka Gramin Bank, Head Office, Ballari within **5.00 pm** on or before **25-11-2022**.
3. The Tender/Auction of the vehicle will be conducted on **28.11.2022**. Highest bidder among the two bidding processes is declared as winner. Interested parties may visit the above address for participation.
4. The application fees & EMD is to be paid through crossed DD favoring of **“Karnataka Gramin Bank”** payable at **Ballari**.
5. The Tenders received shall be opened at Karnataka Gramin Bank, General Administration Wing, Head Office, and Ballari at 11.00 am on 28.11.2022. The offer once made shall be irrevocable.
6. The EMD will be refunded to the respective offerer whose offer is not accepted, no interest shall be payable on the EMD.
7. In case of acceptance of the offer by the Bank, the EMD shall be adjusted against the total price offered by the successful offerer subject to payment of the balance before the stipulated date.
8. The Bank shall require 3 days' time from the date of opening the tender for intimating the acceptance of the offer.
9. In case of failure / default and or refusal of the offerer. Whose offer has been accepted to the balance on the stipulated date, the EMD Rs.5000/- will be forfeited to the Bank by way of liquidated damages and the Bank shall be at liberty to sell the vehicle to any other person and in such other manner as it may deem fit.
10. The Bank reserves the right to reject any offer or cancel / postpone the sale of the vehicle without assigning any reason whatsoever for the same.

11. On payment of the total bid amount, documents relating to the vehicle shall be handed over to the successful bidder to enable him / her name. The successful bidder shall arrange to get the vehicle registered and lift / take delivery of the vehicle, within 3 days or the date stipulated. The taxes / insurance premium that may fall due during this period has to be borne by the successful bidder.
